



### COVID-19 Therapeutics Survey Results and Next Steps

### Background and Purpose

In July 2022, the MDH Highly Impacted Settings (HIS) Unit sent a survey to 680 people at ~114 correctional facilities and ~245 shelters to:

- Understand COVID-19 therapeutics use in these settings
- Identify barriers and facilitators to helping residents access therapeutics

The purpose of the survey was to identify opportunities to increase access to and use of COVID-19 therapeutics in these settings

### Who did we hear from?

**51** people responded to the survey from jails and shelters of all sizes.



#### **Estimated response rates:**


- Overall = 14%
- Jails = **25%**
- Shelters = 9%

At least one jail from every **District Epi Region** responded to the survey, while most shelters were in the metro area.

Most respondents were in positions of leadership.




# Facilities reported little experience helping residents access COVID-19 therapeutics in the past

"Has your facility helped residents access COVID-19 therapeutics in the past?"



# **Opportunity**: Facilities see it as their role to help residents access therapeutics


Over half of respondents reported that **leadership is supportive** of including therapeutics in the facility's long-term COVID-19 management plan.



"Our role is to help residents with things that would make finding and keeping safe housing. That includes their health."

# **Opportunity**: Facilities know how to access COVID-19 tests and where to fill prescriptions

Few respondents reported challenges accessing tests or knowing where to fill prescriptions.



"Local Public Health plays a big part in accessing therapeutics. Our agency uses Public Health to test and treat if needed."

# **Opportunity**: Facilities have someone to screen for basic eligibility


No shelters reported having no one to screen residents for basic eligibility.



### **Barriers**: Shelters reported more barriers than jails.

No barriers to ensuring residents have access to therapeutics Not sure who is eligible for COVID-19 therapeutics Don't know how to access COVID-19 therapeutics Too many competing priorities No transportation to bring residents to provider/pharmacy Other barrier

Have not had any eligible patients



### **Barrier**: Accessing healthcare providers


Don't know how to access COVID-19 therapeutics

No transportation to bring residents to provider/pharmacy

Don't know where to refer residents for clinical evaluation

No one to coordinate health care visits for positive residents

Hard to find willing prescribers

"Our volunteer doctor told us to send people to ER to access therapeutics but the ER said no. You must see your personal doctor. Many of our folks don't have a personal doctor."

"To get therapeutics [residents] had to travel all over while ill."

### **Solutions**: Accessing healthcare providers

- Make telehealth options available to residents (RFP for telehealth provider has been posted!)
- Provide shelters with a **list of referral options** (in progress)
- <u>OEO funds</u> are available to **reimburse for transportation**

It would be helpful to have

"Prescribing onsite and delivering to shelter."


### **Barrier**: Uncertainty about eligibility criteria

A common **misperception** among survey participants was that that COVID-19 therapeutics are only for residents who are **really sick** (i.e., have more than mild symptoms).

Not sure who is eligible for COVID-19 therapeutics

Have not had any eligible patients

Determining eligibility is too difficult



"It's not a barrier so much as we just haven't needed them as the last two cases were very mild symptoms"

"Don't know level of eligibility of our residents."

### **Solutions**: Clarifying eligibility

- Create a basic eligibility screening tool for facilities (in progress)
  - Tests positive for COVID-19
  - Within 5-7 days of symptom onset
  - Has at least one symptom consistent with <u>mild to moderate</u> COVID-19
  - At <u>risk of severe illness</u> from COVID-19

#### Patients with mild illness are eligible!

### **Solutions**: Clarifying eligibility

- Patient education for residents
  - Eligibility criteria
  - Risks and benefits of therapeutics

It would be helpful to have:

"Simple list of education that would let a resident know if they would qualify and the urgency of moving quickly."

"very simple flyer to post about the benefits."

### **Barrier**: Perceived cost barriers

Expect that therapeutics are too costly for residents
3%

"We are interested in therapeutics not sure if we can afford them"

"Identifying and removing barriers that complicate access to the therapeutic including transportation assistance, sliding scale for purchasing therapeutics"

"Offer reduced cost"

### **Solutions** to perceived cost barriers

- Provide **education** on cost of therapeutics
  - Most COVID-19 medications are free, but there could be other costs or fees. If patient has insurance, they should provide that information when you get the medication. If they do not have insurance, they should ask the health care provider or pharmacist about any costs.
- There is **no cost** for testing, assessment or dispensing medication at the 5 <u>community testing sites with Test to Treat</u> capability.


### **Barrier**: Competing priorities and staffing challenges



It would be helpful to:

"...avoid extra burden and cost to [facilities] already understaffed."

Some shelter leadership are **very unsupportive** of including therapeutics in their facility's long-term COVID-19 management plan.



### **Solutions** to competing priorities and staffing challenges

- HHSI pop up testing includes staff to collect specimens
- Emergency staffing pool
- OEO Outbreak Funds (flexible funding)
- Referring residents to Test to Treat sites
- Organizational leadership can do more to communicate their support for therapeutics


"Funding for staffing to allow for on-going testing, assessments and promoting educational material."
